**Preamble**

The Industrial Policy 2015 aims at promoting 'Gujarat' as a globally competitive and innovative industrial destination that stimulates sustainable development and inclusive growth. The primary mission of the Industrial policy includes proactive support for development of SMEs, value addition on local primary sources and increasing the share of manufacturing in State GDP. The new wave of progress has become possible owing to the ambitious and visionary spirit of entrepreneurs of MSMEs. With a view to accelerate the current industrialization process, it is desirable to engineer the growth through recognition. To provide public recognition for outstanding achievements, it is proposed to expand the scope of Awards to Micro, Small & Medium Enterprises in both manufacturing & Export Awards for their productivity, quality, providing employment, innovation, product development, etc. For Micro and Small Entrepreneurs, awards for Women entrepreneur, Young entrepreneur (below 35 years), and SC / ST entrepreneur have been introduced in New Industrial Policy. Also Best entrepreneur Award at regional level have been introduced.

For this purpose a Task Force Committee was constituted to review existing schemes under industrial policy 2009. The Committee analyzed schemes, had discussions with Industries Associations and came out with suggestions for necessary modifications in the scheme to motivate MSMEs to stand in competitive market.

**Resolution**

In view of the strategy under New Industrial Policy the Government is pleased to introduce a "Scheme for Awards to MSMEs & Export Awards"



which will come into force from the dt. 1.1.2015. The Scheme will remain in operation for a period of five year

## **1.0 Definitions**

### **1.1 Micro, Small and Medium Enterprises (MSME)**

An Enterprise , which satisfies the conditions of Micro, Small and Medium Enterprises as per the definition under the MSMED Act 2006 of the Government of India, as amended from time to time, and having acknowledgement of Entrepreneurs' Memorandum EM part-II filed with respective District Industries Centre.

## **2.0 Eligibility**

- I. Enterprises shall have valid EM-II and in continuous production activity at least for last three years.
- II. Enterprises shall have paid Taxes, revenue & dues of Government & other State organizations.
- III. Enterprises shall have valid statutory clearances and licenses as may be applicable.

## **3.0 State Awards to Best MSMEs**

### **3.1 Separate awards to be given for Micro, Small and Medium category**

(a) Three awards to be awarded in each category.

- Growth in production and profit
- Quality and environment improvement measures.
- Innovation in technology for new product or process development

(b) Award of Rs. 2 lakhs, Trophy and Appreciation letter to each winner

### **3.2 Awardsto Best MSEs Entrepreneur in the following category one to each :**

(i)

- a. Woman Entrepreneur
- b. Young Entrepreneur (first generation entrepreneurs below 35 years age)
- c. SC Entrepreneur
- d. ST Entrepreneur

(ii) Award of Rs. 2 lakhs, Trophy and Appreciation letter to each winner.



### **3.3 Award to Best MSME Entrepreneur at regional level one each in five regions:**

- (i)
  - **North Gujarat Region**(Districts: Ahmedabad, Gandhinagar, Mehasana, Patan, Banaskantha, Sabarkantha and Aaravalli)
  - **Central Gujarat Region**(Districts: Kheda, Anand, Mahisagar, Panchmahal, Dahod, Vadodara, Chotta Udaipur)
  - **South Gujarat Region** (Districts: Bharuch, Narmada, Surat, Tapi, Navsari, Valsad, Dangs)
  - **Saurashtra Region** (Districts: Rajkot, Morbi, Surendranagar, Jamnagar, DevbhumiDwarka, Porbander, Junagadh, Somnath-Gir, Amreli, Bhavnagar, Botad)
  - **Kutch Region**
- (ii) Award of Rs. 1 lakh, Trophy and Appreciation letter to each winner

### **3.4 Export Awards:-**

- (i) Manufacturing exporters from Medium Industries ( one Award each to 10 commodity group)
- (ii) Manufacturing exporters of Micro & Small Enterprise (One Award each to 10 commodity group)
- (iii) 100% Export-Oriented Units (EOU) (One Award)
- (iv) Micro and Small Enterprise: (One Award to each category)
  - a. Women Manufacturer Exporter
  - b. Schedule Caste Exporter
  - c. Schedule Tribe Exporter
- (v) Product Group A & B as per Annexure -1, will be rotated alternatively for Award category 1 & 2
- (vi) Award of Rs. 1 lakh, Trophy and Appreciation letter.

### **4.0 Procedure:**

- ❖ Industries commissioner will invite the application for all award group through advertisement in local newspaper having wide publicity (all editions).
- ❖ Industries Commissioner shall prescribe application forms, procedure for application & constitute working committee for ranking of the applications to recommend SLIC for selection.
- ❖ The list of selected enterprises shall be notified & informed by Industries Commissioner to the enterprise regarding Award Distribution Ceremony.

**Group-A**

1. Engineering and Electrical goods
2. Primary chemical cosmetics including paints and intermediates, fine chemical, soap, incense sticks, essential oil, perfumeries.
3. Chemicals and its products, paints, paper and paper products.
4. Hide products including tanned hides and ready tanned rubber products and resins
5. Frozen and tin-packed fruit, vegetables and processed food including meat (except sea-food & marine products)
6. Cotton silk, man-made yarn and fabrics
7. Minerals and mineral-based products
8. Jewellery and Ornaments
9. Diamond cutting & polishing
10. Manufactured goods not covered in Group A & Group B

**Group-B**

1. Electronics production and Information Technology
2. Drugs and pharmaceuticals
3. Plastic and Linoleum products
4. Processed sea-food including different types of frozen and tinpacked fish and other marine products
5. Spices, vegetable oil cake, tobacco and tobacco products, esabgool etc.
6. Ready-made garments, hosiery, made ups etc.
7. Products of handicraft and handloom
8. Herbal medicines, ayurvedic products, medical, herbal, Indian system of medicine products
9. Castor oil and its products (edible and inedible)
10. Manufactured goods not covered in in Group A & Group B
